Bloom opened the Budget Hearing of the fiscal year 2019-2020

Wendt questioned the Solid Waste Page 9, that expenditure will be in the red by approximately \$475 if we stay with the current revenue. This will addressed and added to the agenda under Supervisor report.

Minutes: Hoover made a motion to accept the Regular Board Meeting Minutes from Jan. 8, 2019 as written supported by Pitch. All in favor, Motion carried

Introduction of Guest: No guests

Public Comments:

Comment: Gary Parish a Mills resident who lives on Dublin Road between Hull & Baker made a request to have the road repair/upgrade put on a list for future work. There are now 4 homes on that road and it is impassible with the spring weather, garbage will not come down, school bus does come down.

Answer: Wendt commented that the money has been allocated for this year but the board may have some money next year to do some gravel projects. It would cost approx.. \$15000.to gravel a ½ mile, but it would possibly be split with Hope Twp since it is on the line. Bloom suggested he talk with Hope Twp. also.

Bloom read a letter that he had sent to the Township Attorney about the incident on Nov. 5th the day before the election, involving Amy Hoover and Denise Mason present at the township hall office. Ann Manary was also notified of the incident. Discussion ensued between Bloom, Greg & Denise Mason and Pitch. Bloom stated that it was time to move on with the board meeting, Greg Mason would not cease and in sued in name calling and using foul language. Bloom warned him that he needed to stop or he would have to call the Midland Police Dept. to have him removed from the meeting. He continued, forcing Bloom to call them..

Community Center Cook Stove: Having issues with the stove and had it serviced and the fire suppression system is not up to date. Parts are expensive for the stove and the quote to update the fire suppression system is \$2174.00. So we are trying to consider what other options there are, possibly replacing the stove with regular gas or even electric models. We are working on a solution.

DEQ: city water plant meeting: Because of the Flint water crisis, they are imposing a twice a year test be sent to Lansing to be looking for lead and copper. We would be responsible to identify 15 homes and pick 10 of those homes to be tested twice a year at a cost to the township of \$75 per sample for a total \$1500 annually. Discussion was held.

C. Fire Dept. Report: Fire Chief Metzger read his Report Total Responses for 2019: 31 calls, with 13 calls since last meeting. Total mutual aid calls since last meeting: 1 structure fire in Larkin Twp.
