- D. Blight Ordinance infraction: Bob Butters at 2547 E. Baker Rd, running a business out of there with no permit from the township. Motion made by Bloom to have the authority to use the township attorney and if possible ticket the rightful owner, supported by Pitch. - E. Committee Recommendations: The committee is asking that a guideline be in writing for the procedure of checks and balances for paying the bills. Discussion was held. Sweet and Pitch will adopt a resolution on the procedure for doing this.
