- B. Supervisor's Report: The two properties that have blight issues: Two tickets have been issued Motion made by Bloom that he will send a letter to the occupant at 2547 E. Baker Road stating that he is in violation of the zoning ordinance and he has 30 days in which to cease all business operations at that address; supported by Wendt. Roll Call Yes Hoover, Wendt, Bloom, Pitch, Sweet Motion carried. Motion made by Wendt that if the Past Due Response Invoice issued to 2547 E. Baker Road is not paid by May 16, 2020 the township will take appropriate legal measures to put a lien on the property; supported by Pitch Roll Call Yes Hoover, Wendt, Bloom, Pitch, Sweet Motion Carried. The DEQ has finished its investigation; loader is still there and the case is being turned over to the State Wet Lands Division. The township will receive copies of the report when available.
- **C. Fire Dept. Report:** Fire Chief Metzger read his Report:

5 responses since last meeting; 55 total responses for 2020 Dept. Activities:

- 1. Contact made with Sharon Mortensen at the Midland Foundation and was given a contact regarding the roof project; She said the Grant cycle is suspended till Fall.
- 2. Cost recovery Invoice Final Notice was sent to the property owner at 2547 E. Baker Rd for Hazardous Material Response.

3. Occupant at 5630 N. Sturgeon Rd was contacted and he acknowledges he is in violation of the Building Code and stated he will be moving by July 1, 2020.

Department requests:

- 1. To apply for the Midland Foundation Town Matching Grant for \$5000. To be applied to the roof project.
- 2. To apply to the Midland Foundation for the remainder of the roof project funds, which would be considered in August with funds being disbursed in late September.
- 3. To contact Trevillian Construction to install the Fire Station/Hall roof

Wendt made a motion to grant the Fire Dept. requests with the Roof project not to exceed \$21,000. and the bill being split 50-50 between the Fire Dept. and General Fund, supported by Pitch Roll Call Yes - Hoover, Wendt, Bloom, Pitch, Sweet Motion Carried
