- **B.** Fire Hydrants Servinski Sod proposed an estimate to cut the brush, spray and clean up around necessary fire hydrants. This had not been done since 2018. Wendt made a motion to accept the estimate and allow Servinski Sod to do the work for a cost of up to \$30 each for Brush cutting and spraying per hydrant, supported by Hoover Roll Call Yes Hoover, Wendt, Bloom, Pitch, Sweet Motion Carried
- **C.** Board of Review Checks: Motion made by Bloom to pay the BOR Members for the July organizational and public meeting, supported by Pitch. Roll Call Yes Hoover, Wendt, Bloom, Pitch, Sweet Motion Carried

Wendt: Park has been used for some ball games, Road Commission has canceled all projects at this point. If they receive some disaster relief money, they might do some gravel projects. Right now everything is on hold till funding is available.
