- A. Snow Plowing Servinski winter Contract: The 2020-2021 Bid has increased slightly-Fire Dept \$40 (\$5 increase), Hall \$60 (\$10 increase)10, Park \$130 (\$20 increase) Parking Lot Salting \$165/Ton as needed. Last increase was 2016-2017. - B. Solid Waste Special Assessment: Cost has increased for Trash and Recycling services. Bloom moved to set the Solid Waste Special Assessment at \$190.00 per parcel/per Resident for the coming year, supported by Wendt Discussion held Roll Call Yes Hoover, Wendt, Bloom, Sweet Motion Carried
- C. Blight, Junk Yard Complaint: A anonymous complaint was given to Supervisor Bloom for Blight/Junk Yard at 5920 N. Jefferson Road. Bloom spoke to the residents there and felt that the complaint was unsupported at this time. They do have a privacy fence surrounding their back yard. Discussion held

Comment Wendt: With Sanford wanting to use the ball diamonds - looking at what work needs to be done at the diamonds and what equipment they can use that we have in storage. Most of the equipment is old and outdated. Discussion was held and The Board is in agreement that any outdated or unusable equipment should be thrown away, but will still keep the ATV for now.

Comment Wendt: The back ball diamond closest to the walking track has an issue with the outfield. He received an estimate of possibly 15,000-\$18,000. To bring it up to level working order. Sanford Little League is discussing what they might want to do about the diamond and whether they will want to use it. Discussion held.
